

Rau peb ib tsoom hauv tsev kawm ntawv,

Tus kab mob COVID-19—paub raws li *novel coronavirus* rau 2019—kis ntau ntxiv thoob ntiaj teb, peb qhia rau UW-Madison cov xibfwb, neeg ua num, thiab meejig tias qhov yuav kis tau rau hauv tsev kawm ntawv muaj tsawg.

UW-Madison koom nrog *Public Health Madison & Dane County*, [Wisconsin Department of Health Services](#), thiab lub *Centers for Disease Control (CDC)* xyuas tas li tus kab mob kis thoob ntiaj teb no. Yog ntseeg tias leej twg yuav muaj taus tus kab mob COVID-19 lub [Public Health Madison & Dane County](#) yuav tiv tauj nws.

Raws CDC cov kev qhia, UW-Madison tau kaw kev mus kawm ntawv txawv teb chaws nyob rau *Italy*, Kauslim Qab Teb, thiab Suav Av Loj. Tau kom cov meejig rov los rau lawv qhov chaw nyob ruaj nyob tebchaws Asmeska, nyob nrug lwm tus 14 hnub (nyob hauv tsev thiab txhob mus haujlwm, kawm ntawv, ua si los koom tej qhov muaj neeg coob tuaj) thiab ntsuam lawv kev ua npaws, hnoos, thiab ua tsis taus pa tom qab los txog. Peb tsis xav tias cov coob ntawm cov meejig rov los no yuav cia li rov tuaj rau hauv tsev kawm ntawv UW-Madison. Tsev kawm ntawv muaj kev txhawb thiab ntaub ntawv txog chaw pab rau txhua tus meejig yuav tau rov los rau tebchaws Asmeska.

Lub CDC thiab cov neeg ua num rau kev kuaj mob hauv Wisconsin tau qhia lub asthiv no tias tebchaws Asmeska tab tom npaj rau qhov tias yuav muaj kis tau rau neeg coob tus. Thaum muaj li no, cov kev npaj yog yuav muaj tuaj tsawg ua ub no rau hauv tsev kawm ntawv. [University Health Services \(UHS\)](#) tseem niaj hnub koom nrog cov chaw kuaj mob rau pejxeem thiab cov chaw kuaj mob hauv zej zog xyuas kom thaum muaj li no, tsev kawm ntawv txo los txwv tau kom txhob kis ntxiv.

UW-Madison kuj nrog cov thawj coj npaj qees xyuas kom muaj kev noj qab haus huv thiab nyabxeeb thoob plaws rau hauv tsev kawm ntawv. Txij thaum tus kab mob H1N1 xyoo 2009, peb tau tsim ib co kev ua raws thiab qauv uas peb tab tom rov muab los xyuas thiab kho pauv.

Li ntawd koj yuav tau ua dabtsis tiv thaiv koj tus kheej?

Tam sim no, *UHS* kom ua raws li cov kev pab tswj noj qab haus huv nram no kom txhob mob:

- Siv xab npum thiab dej ntxuav ob sab tes
- Txhob siv ob sab tes tsis tau ntxuav kov ob lub qhov muag, qhov ntswg thiab qhov ncauj
- Txhob nyob ze cov neeg muaj mob
- Nyob tom tsev thaum mob lawm
- Npog qhov ncauj thiab qhov ntswg thaum hnoos los txham, thiab hnoos thiab txham rau sab caj npab los tes tsho
- Mus saib ntxiv [UHS COVID-19 informational website](#), ntawm uhs.wisc.edu. Lub website muaj ntau yam txog kev pab, kev hqia ntxiv, thiab cov lus teb neeg nug tas li txog COVID-19. Thov siv caij twm cov lus neeg nug tas li (*FAQ*).

Nws tseem ceeb nco tseg tias peb sawv daws muaj lub luag haujlwm nrog qhov no thiab yuav tsum muaj kev txhawj txog thiab to taub. COVID-19 tsis yog rau ib haiv neeg los ib cev nqaij dam tawv. Yuav tsis pub muaj kev saib tsis taus los ua phem vim tus neeg cev nqaij daim tawv los tau mus yos qhov twg los. Yog koj raug kev saib tsis taus los ua phem, peb cuab koj zog kom qhia thiaj muaj kev xyuas pab raws qhov teeb meem.
